Ordinance No. 2012-324

**AN ORDINANCE OF THE BOROUGH OF NEWBURG, CUMBERLAND COUNTY, PENNSYLVANIA, SETTING THE REAL ESTATE GENERAL PURPOSE TAX RATE OF 1.25 MILS FOR THE YEAR 2013 AND SUCCEEDING YEARS UNTIL AMENDED BY BOROUGH COUNCIL**

BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Newburg, Cumberland County, Pennsylvania, pursuant to the Borough Code, as follows:

Section 1. Tax Levy A tax is hereby levied upon all real estate and property in the Borough of Newburg subject to tax of the Borough for the year 2013, at the rate of 1.25 mils on each dollar of assessed valuation as provided by law for general and other Borough purposes. This tax rate of 1.25 mils shall be levied for years after 2013 until amended by Borough Council.

Section 2. Tax Discount and Penalty For the year 2013, and for each year subsequent thereto, all taxpayers required to pay the Borough of Newburg real estate property tax shall be entitled to a discount of two (2) per centum from the amount of such tax upon making payment of the whole amount due thereof within two (2) months after the date of the tax notice. All tax payers who shall fail to make payment of the real estate property tax charged against them for four (4) months after the date of the tax notice shall be charged a penalty of ten (10) per centum, which penalty shall be added to the taxes by the tax collector and shall be collected by said tax collector.

Section 3. Repealer. All provisions of previous ordinances of the Borough of Newburg, or parts thereof, which are contrary or inconsistent to this Ordinance are expressly repealed.


Section 4. Savings Clause. In all other respects, the ordinances of the Borough of Newburg shall remain as previously enacted and ordained.


Section 5: Effective Date. This Ordinance shall take effect January 1, 2013.




