**A RESOLUTION OF THE BOROUGH OF NEWBURG,
CUMBERLAND COUNTY, PENNSYLVANIA TO APPOINT
SARA RHINE AS THE SECRETARY FOR THE BOROUGH
OF NEWBURG**

WHEREAS, pursuant to section 1005 of the Borough Code, 8 Pa. C.S. § 1005, the Council for the Borough of Newburg (the "Borough") has the authority to appoint a qualified individual to serve as the Borough Secretary; and

WHEREAS, the Borough Council desires a Secretary to perform the duties of that office as defined in section 1111 of the Borough Code, 8 Pa. C.S. § 1111; and

WHEREAS, there is a vacancy in the office of Secretary for the Borough and the Borough advertised the position and solicited applications from qualified individuals to fill the vacancy; and

WHEREAS, the Borough Council received applications from various individuals, and after interviewing the best candidates concluded that Sara Rhine was the most qualified to serve as the Secretary for the Borough.

NOW THEREFORE, BE IT RESOLVED, by the Council for the Borough of Newburg as follows:

SECTION 1. The above recitals are incorporated herein by reference hereto.

SECTION 2. The Borough Council hereby appoints Sara Rhine to serve as Secretary for the Borough to perform the duties and exercise the powers of that office.

SECTION 3. The Borough Council hereby sets the compensation for Sara Rhine at \$431.66 per month.


SECTION 4. Effective Date. This Resolution shall become effective immediately.

In the event any provision, section, sentence, clause, or part of this Resolution shall be held invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause, or part of this Resolution, it being the intent of Borough Council that such remainder shall be and shall remain in full force and effect.

SECTION 6. Repealer. All resolutions or parts of resolutions inconsistent herewith are expressly repealed.






