**RESOLUTION NO. 2007- 10**

A RESOLUTION OF THE BOROUGH OF NEWBURG AMENDING THE SCHEDULE OF FEES SET FORTH IN ORDINANCE NO. 2007- Z , FOR THE REGISTRATION, LICENSING, AND RE-INSPECTION OF RENTAL UNITS WITHIN THE BOROUGH.

**Now Therefore, Be it Resolved**, by the Council for the Borough of Newburg that the schedule of fees set forth in Section 10 of Ordinance No. 2007- Z , regarding the licensing and inspection of rental units within the Borough and enacted August 6, 2007, is amended as follows:


1. Rental Registration: The fee for the initial Rental Registration shall be fifty dollars (\$50.00) per rental unit. No fee will be required to renew the Rental Registration.
2. Rental License: If the Rental Registration fee of \$50.00 is paid, no fee will be required for the initial Rental License. The initial Rental License shall expire three years after the issuance of the initial Rental Registration. Subsequent renewals of the Rental License shall be valid for three years. The fee to renew the Rental License is fifty dollars (\$50.00) per rental unit.
3. Re-inspections: The fee for the second and all subsequent re-inspections shall be twenty-five dollars (\$25.00) per rental unit. This fee of \$25.00 shall also apply to Section 6.C.
4. Reinstatement: The fee to reinstate a revoked Rental Registration or Rental License shall be twenty-five dollars (\$25.00).
5. Effective Date: This Resolution shall become effective January 1, 2008.


