BOROUGH OF NEWBURG  
CUMBERLAND COUNTY, PENNSYLVANIA  
ORDINANCE NO. 2019-02**

**AN ORDINANCE OF THE BOROUGH OF NEWBURG, CUMBERLAND COUNTY,  
PENNSYLVANIA, FIXING THE TAX RATE FOR THE YEAR 2019**

WHEREAS, the Borough Council for the Borough of Newburg has the authority under the Borough Code, 8 Pa.C.S. § 1302(a) to levy and collect annually taxes for general borough purposes.

BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Newburg, Cumberland County, Pennsylvania, as follows:

**Section 1.** A tax is hereby levied on all real property within the Borough of Newburg subject to taxation for the year 2019 as follows:

Tax rate for general purposes, the sum of 2.25 mills on each dollar of assessed valuation.

This ordinance establishes a total tax rate for all Borough purposes of 2.25 mills for the year 2019 and all succeeding years until amended by Borough Council.

**Section 2.** For the year 2019, and for each year subsequent thereto, all taxpayers required to pay the Borough of Newburg real estate property tax shall be entitled to a discount of two (2) per centum from the amount of such tax upon making payment of the whole amount due thereof within two (2) months after the date of the tax notice. All tax payers who shall fail to make payment of the real estate property tax charged against them for four (4) months after the date of the tax notice shall be charged a penalty of ten (10) per centum, which penalty shall be added to the taxes by the tax collector and shall be collected by said tax collector.


**Section 3.** Any ordinance, or part thereof any ordinance, conflicting with this ordinance is hereby repealed insofar as the same affects this ordinance.


**Section 4.** Notice shall be given in accordance with the provisions of the Borough Code.


**Section 5.** The provisions of this Ordinance are severable and if any of its sections, clauses, or sentences shall be held illegal, invalid or unconstitutional, such provisions shall not affect or impart any of the remaining sections, clauses or sentences.

**Section 6.** This Ordinance shall be effective immediately.


