RESOLUTION NO. 2019 – 02

A RESOLUTION OF THE BOROUGH OF NEWBURG ASSIGNING OFFICER NUMBERS TO THE CODE ENFORCEMENT OFFICER AND THE ASSISTANT CODE ENFORCEMENT OFFICER OF THE BOROUGH OF NEWBURG FOR THE PURPOSE OF AUTHORIZING THEM TO ENFORCE BOROUGH ORDINANCES THROUGH THE ISSUANCE OF CITATIONS WITH THE MAGISTERIAL DISTRICT COURT.

WHEREAS, Borough Council for the Borough of Newburg (“Borough Council”) has in the past appointed the Mayor to the position of Code Enforcement Officer, and the Secretary to the position of Assistant Code Enforcement Officer; and

WHEREAS, Borough Council desires to assign Officer Numbers to the Code Enforcement Officer and Assistant Code Enforcement Officer, for the purpose of enforcing Borough ordinances through the issuance of citations with the Magisterial District Court; and

WHEREAS, Borough Council desires to assign Officer Number CE1 to the Code Enforcement Officer, and Officer Number CE2 to the Assistant Code Enforcement Officer.


NOW THEREFORE, BE IT RESOLVED by the Council for the Borough of Newburg as follows:

1. The above recitals are incorporated herein by reference hereto.
2. Borough Council assigns the Officer Numbers, set forth in Sections 2 and 3 below, for the purpose of authorizing the relevant officials to enforce Borough ordinances through the issuance of citations with the Magisterial District Court.
3. Officer Number CE1 is assigned to the Mayor, as Code Enforcement Officer for the Borough of Newburg.
4. Officer Number CE2 is assigned to the Secretary, as Assistant Code Enforcement Officer for the Borough of Newburg.
5. Effective Date: This Resolution shall become effective immediately.
