RESOLUTION NO. 2019 - 004

**A RESOLUTION OF THE BOROUGH OF NEWBURG ACKNOWLEDGING
THE HOPEWELL TOWNSHIP TAX COLLECTOR, HARRY KILLIAN, AS
BOROUGH OF NEWBURG TAX COLLECTOR FOR THE REMAINDER OF THE
CURRENT TERM OF OFFICE**

WHEREAS, the Borough of Newburg (the "Borough") is a Pennsylvania municipal corporation and is a taxing district as defined in the Local Tax Collection Law; and

WHEREAS, Hopewell Township (the "Township") is a Pennsylvania municipal corporation, being a second class township, and is a taxing district as defined in the Local Tax Collection Law; and

WHEREAS, Cumberland County (the "County") is a Pennsylvania municipality, being a third class county, and is a taxing district as defined in the Local Tax Collection Law; and

WHEREAS, the Borough has been unable to fill the position of tax collector for its municipality; and

WHEREAS, the Borough and Township, being conveniently located, desire to enter into an intergovernmental agreement as authorized by the Intergovernmental Cooperation Act, 53 Pa.C.S. §2301 et seq., for the purposes of having the Township tax collector collect the taxes of the Borough and creating a joint tax collection district, as authorized by Section 4b of the LTCL, 72 P.S. §5511.4b; and

WHEREAS, Borough Council desires to utilize the services of Harry Killian, the tax collector for Hopewell Township; and

WHEREAS, the County desires to confirm this arrangement prior to the printing of tax bills.


NOW THEREFORE, BE IT RESOLVED by the Council for the Borough of Newburg as follows:

1. The above recitals are incorporated herein by reference hereto.
2. Hopewell Township's tax collector, Harry Killian, has agreed to serve as the Borough of Newburg's tax collector, and the Township has agreed to permit Harry Killian to provide services to the Borough.

3. The Borough and the Township will each adopt an ordinance authorizing an Intergovernmental Cooperation Agreement between the Borough and the Township, whereby the Township tax collector, Harry Killian, will serve as the Borough's tax collector for the remainder of the current term.
4. Effective Date: This Resolution shall become effective immediately.




